ENTRY FEE is \$50.00 (including \$.50 AKC Recording Fee & \$1.50 AKC Event Services Fee)
RECORDING FEE of \$.50 is required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This recording fee is to be collected by the show giving club and paid to the AKC. This fee is included in the entry fee.
MAKE ALL CHECKS PAYABLE TO: BCDTC. Mail entries to the Test Secretary, Lynn Millar, 19 Spring Lane, Fleetwood, PA 19522. Non-TD dogs MUST include a current copy of certification by a licensed tracking judge. This test is limited to 5 dogs.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES THEREOF WITHOUT THE AGREEMENT AND RULES ON THE REVERSE SIDE ARE NOT ACCEPTABLE.
NO ENTRY FEE will be refunded after the closing date, with the exception of the entry fee for an alternate that does not participate. This refund shall be made within 7 days following the Test.
